SENATE OF PAKISTAN SENATE DEBATES

Friday, the October 21, 2022

The Senate of Pakistan met in the Senate Hall (Parliament House) Islamabad at thirty four minutes past ten in the morning with Mr. Chairman (Muhammad Sadiq Sanjrani) in the Chair.

Recitation from the Holy Quran
