### 81. \***Mir Wali Muhammad Badini:** (Notice received on 19-05-2010 at 13:10 p.m.)

Will the Minister for Health be pleased to state whether there is any proposal under consideration of the Government to establish an hospital in Gwadar?

**Makhdoom Shahabuddin:** There is no such proposal under consideration of the Federal Government to establish a Hospital in Gwadar.

82. \*Mr. Abdul Haseeb Khan: (Notice received on 19-05-2010 at 13:15 p.m.)

Will the Minister for Health be pleased to state the steps taken by the Government for preparation of a law on eradication of thalassaemia in the country?

**Makhdoom Shahabuddin:** The Ministry of Health is cognizant of the need for legislation to control and eradicate Thalassaemia in Pakistan. The Ministry has collaborated with two Members of the National Assembly's Standing Committee on Health for the purpose of drafting appropriate legislation. This draft has been introduced into the lower house and has been referred to the Committee. The Ministry of Health would support this Bill and anticipate that it would be forwarded to the upper house in due course of time.

83. **\*Mr. Abdul Haseeb Khan:** (Notice received on 19-05-2010 at 13:15 p.m.)

Will the Minister for Health be pleased to state the criteria laid down for, giving prices to different brands of medicines of "the same molecule"?

**Makhdoom Shahabuddin:** Prices of medicines are regulated by the Federal Government under Section 12 of the Drugs Act, 1976.

### PRICING PROCEDURE

Since April 2004 uniform prices of drugs are fixed on the basis of following laid down parameters:—

(a) NEW CHEMICAL ENTITIES

(I) Prices are fixed at an average of the prices prevailing in the SAARC countries. In case thê drug is not available in the SAARC countries, international prices (particularly Australia / New Zealand) are considered.

(II) Prices as mentioned in the proforma invoice for imported drugs and costing data for locally manufactured drugs are also considered for new chemical entities besides other parameters.

Imported drugs

MRP=C&F + 40% Markup

Locally manufactured drugs

Non-Sterile Products

MRP=Prime Cost + 75% Markup

Sterile Products

MRP=Prime Cost + 90% Markup (Note-The Markup is allowed to cover the expenses /discounts.)

(b) GENERIC DRUGS

Uniform prices are fixed for generics as summarized below:----

- (i) Minimum 15% less than the brand leader price at the time of registration of first generic.
- (ii) Average price of earlier same composition(s) / generic(s) registered in the country in case Pricing Committee has not yet fixed the price of a medicine formulation.
- (iii) Prices of new strength of medicines are awarded on pro-rata of price of same composition / generic fixed by the Drugs Pricing Committee.
- (iv) Demanded price is issued in case it is less than the fixed price.

**Makhdoom Shahbabuddin:** Imported drugs are registered under section 7 of the Drugs Act, 1976 by the Drugs Registration Board. The registration is granted keeping in view the safety, efficacy, quality and economic value of the drug.

Makhdoom Shahabuddin: (a) Pollen Allergy Patients in last 03 years in Islamabad have been as follows:—

- (b) The Government has taken following steps to control the said disease:—
- (i) An Allergy Centre is functional at the National Institute of Health since 1981, which conducts skin prick test with specific extracts for diagnosis of allergy and thereafter provides specific allergy vaccines accordingly to the patients found allergic.
- The said centre is providing technical advice and having close coordination (ii) with concerned civic authorities and departments for control and prevention of environmental allergies.
- (iii) Apart from treating such patients . throughout the year to facilitate allergy patients, the Emergency Departments of all Government Hospitals in Islamabad remain on high-alert and manage patients of acute pollen allergy during spring season when there are very high pollen counts in the environment.

- (iv) The printed informative material for information and awareness of Allergy patients is under printing and will be provided to the patients (Annex-1).
- (v) In view of the increased demands, the PC-I for the "Establishment of a Centre of Excellence for the Allergy with Diagnostic and Curative Facilities" (03 years duration) has been approved at a cost of Rs.39.876 M at the National Institute of Health where the construction work has already started since March 2010.

**Mr. Nazar Muhammad Gondal:** Wheat crop for the year 2008-09 production target was 25 million tons and the actual production (2008-09) achieved was 24.03 million tons.

The Pakistan Agricultural Storage and Services Corporation (PASSCO) and provincial Food Departments have stored the procured wheat in the available storage/godowns. While the additional wheat was stored on raised plinth in the open. All possible protection measures and care has been adopted to save it from losses. Efforts are also being made to enhance the proper wheat storage capacity in the country.

(b) The contracts for installation of water filtration plants stand awarded and signed by the respective Provincial Governments, FATA Gilgit Baltistan and AJK Governments. It is expected that during the year 2010-11.5507 water filtration plants shall be installed, subject to availability of funds.

(b) Pakistani Missions provided all possible assistance to those students, during their study program, before and after their expulsion.

(c) The Missions provided lawyers access to the students in those countries, where the local laws allowed. However, no lawyer access was provided to the students of a scholarship program fully funded by the host Governments, and were deported on disciplinary grounds.

(d) The Government of Pakistan has taken every possible measure to request the host Governments to revise their decisions of expelling these students.

# 1. **Establishment of the first ever SME Credit Guarantee Fund** worth 10 billion. **SMEs unable to produce collateral for bank loans benefit from this facility.**

2. **Venture Capital Fund** of PKR 10 billion shall be financed in the same manner as the SME Credit Guarantee Fund.

3. With a view to promote industrialization and value addition and or promotion of exports, an **Export Investment Support Fund** worth PKR 40 billion has been established.

## **PSDP** related interventions aimed at reviving the industrial sector:

- The objectives targeted in our PSDP (2010-11) aim at rejuvenating the industrial sector through 45 projects worth Rs. 3.22 billion with focus on;

The total crops/seeds produced from difference experiments are being utilized as a seeds for the plantation of research trails, zonal varietals testing trails in the different locations of the country. The remaining quantity is distributed among the farmers free of cost as well as on concessional rates for seeds multiplications.

- (a) the percentage of increase in prices of fertilizers in the country during the last two years and its reasons; and
- (b) the steps being taken by the Government to reduce the price of fertilizers?

## Mir Hazar Khan Bajrani: (a)

- a. During the last two years the prices of fertilizer have shown a mixed trend.
- b. The prices of Phosphatic and potash fertilizers decreased while average price of urea showed an increase by 6%. The main reason for this increase is inflation which resulted in increase of costs of business.
- c. The average urea price during the year 2008-09 remained Rs.799.
- d. However, due to recent gas curtailment the cost of production temporarily increased resulting price of bag up to Rs.885/bag. (Details of change in fertilizer during the last two years is at **Annex**).
- (b) i. The government is providing subsidized feedstock gas forproduction of the fertilizer. The price of a locally manufactured 50kg bag of urea is almost half the cost of imported fertilizer.

- ii. A Committee headed by the Minister for Industries & Production include Minister for Food and Agriculture as well as a Senior representative from the Ministry of Finance meets regularly to ensure this objective.
- iii. To meet the electricity shortage, gas from fertilizer sector has been temporarily diverted to power sector to provide relief to the public from load shedding.
- iv. Ministry of Petroleum & Natural Resources and Ministry of Water & Power are exploring possibilities of using alternate unutilized gas sources so that gas supply can be restored to fertilizer sector.
- v. Fertilizer manufacturers have assured that urea price will be reversed to Rs.780/bag if gas supply is restored.

**Makhdoom Shah Mehmood Qureshi:** A total of 19 Pakistanis are currently detained at US Detention Facility in Bagram. A team of our Embassy in Afghanistan has visited Bagram and met with the concerned authorities for the release of Pakistani detainees. Moreover, a formal request has been made to US Embassy in Kabul for handing over custody of these detainees. The Joint Task Force 435 which is dealing with the Bagram detainees, have recommended to the concerned authorities for handing over the detainees to Pakistani authorities. However, final decision on this matter is still awaited (Details of the 19 Detainees held at Bagram are attached as Annexure-A).

Our Embassy is continuing to pursue the matter with the US Embassy in Kabul for the release of these Pakistani detainees from the US Detention Centre in Bagram.
