DEFERRED QUESTIONS

(Question Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 and 11 were originally set down for answering on 3rd June, 2010 (62nd Session) but were deferred)

1. ***Mr. Muhammad Zahid Khan:** (Notice received on 19-05-2010 at 12:55 p.m.)

Will the Minister Incharge of the Cabinet Division be pleased to state:

- (a) *whether it is a fact that previous service rendered by the employees of Intelligence Bureau reinstated in pursuance of the provisions of the Sacked Employees(Re-instatement) Ordinance, 2009, is not being counted for their seniority; and*
- (b) *whether it is also a fact that departmental identity cards have not been issued to the said employees so far; if so, the steps taken by the Government in this regard?*

Minister Incharge of the Cabinet Division: (a) The case of employees of Intelligence Bureau reinstated in pursuance of the Sacked Employees (Reinstatement) Ordinance 2009 was referred to the Anomaly Committee for clarification / guideline whether the reinstated employees in IB are amenable to lose seniority etc under Section 10 of the Sacked Employees (Reinstatement) Ordinance-2009. In response, Anomaly Committed has intimated that “as per Section 10 of the Ordinance the reinstated employees shall not be entitled to claim seniority same as provided in the Ordinance and shall be required on reinstatement to submit a surety bond in the form specified for the purpose”. Therefore, IB reinstated employees are not entitled to claim their previous service to be counted for their seniority. (Copy Annexed).

(b) Employees who got reinstated under Sacked employees (Reinstatement) Ordinance, 2009 have also been issued with departmental Identity Card.

2. ***Mr. Muhammad Talha Mahmood:** (Notice received on 19-05-2010 at 13:00 p.m.)

Will the Minister for Finance, Revenue and Planning and Development be pleased to state:

- (a) whether it is a fact that the posts of Assistant Accounts Officers and Accounts Officers belonging to Pakistan Audit and Account Services (Departmental Cadre) under the control of Controller General of Account Offices have been upgraded from BPS 16 to 17 and from BPS 17 to 18 respectively;*
- (b) whether it is also a fact that the posts of Audit Officers and Assistant Audit Officers of the same group and cadre under the control of Auditor General of Pakistan have not been upgraded, if so, its reasons, and*
- (c) the steps being taken by the Government to remove the said anomaly?*

Ms. Hina Rabbani Khar: (a) Yes, it is correct that posts of Assistant Accounts Officers and Accounts Officers have been upgraded from BS-16 to BS-17 and BS-17 to BS-18 respectively.

(b) This is not correct. The posts of Audit Officers and Assistant Audit Officers have been upgraded *vide* Notification of the Office of Auditor General of Pakistan dated 18-05-2010 (Annexed).

- (c) There is no anomaly.
3. ***Mr. Abdul Haseeb Khan:** (Notice received on 19-05-2010 at 13:15 p.m.)

Will the Minister Incharge of the Cabinet Division be pleased to state the names and other particulars of the persons who were nominated for civil awards on 14th August 2009 and conferred on 23rd March 2010 indicating also the performance / achievements on the basis of which the awards were conferred in each case?

Minister Incharge of the Cabinet Division: Pakistan civil awards are conferred by the **President of Pakistan** on Pakistanis and Foreign nationals under the provision of Article 259 (2) of the Constitution, 1973 read with Decorations Act, 1975. These awards are announced on Independence Day (14th August) and conferred on the following Pakistan Day (23rd March) each year.

The names & particulars of the persons who were nominated by various awards committees for grant of civil awards announced on 14th August, 2009 and conferred on 23rd March, 2010 is at Annex-I.

Will the Minister Incharge of the Cabinet Division be pleased to state:

- (a) *whether it is a fact that there is acute shortage of water in Block Nos. 148, 149 and 157, Cat-III, G-11/4, Islamabad if so, its reasons; and*
- (b) *the steps being taken by the Government to overcome the said problem?*

Minister Incharge of the Cabinet Division: (a) (1) In the wake of persistent dry spell and depletion of ground water resources. the Capital City is experiencing acute water shortage(s).

(2) Water to all Blocks including Block Nos.148, 149 & 157. Cat-111, G-11/4 is being supplied from E-10 reservoir on alternate days/rotation basis.

(3) The drought has also affected water supply to Block Nos.148, 149 & 157. Cat-III, G-11/4. CDA is thus. forced to reduce water supply to these localities. However. the situation is mitigated by supply of water through water tankers to the areas to meet their essential demands. CDA is nevertheless, expecting, that consequent to Monsoon rains, the supply of water to the inhabitants of Capital City would he improved considerably.

(b) Following, steps have been taken by CDA to improve supply of water to the affected areas:—

- Major leakages have been repaired and people are being encouraged to conserve water.

- Non functional tube-wells have been made functional, by carrying out necessary repairs.
- CDA's water tanker service has been improved.
- Some senior officers/officials of water supply wing have been re-shuffled to make the management more efficient.

8. ***Prof. Khurshid Ahmed:** (Notice received on 20-05-2010 at 10:30 a.m.)

Will the Minister for Finance, Revenue and Planning and Development be pleased to state:

- (a) *the categories of Pakistani and foreign nationals who are exempted from payment of Income tax and the reasons for such exemption; and*
- (b) *the names of Foundations and hospitals etc. which are exempted from payment of income tax?*

Ms. Hina Rabbani Khar: (a) ♦ Under the provisions of Income Tax Ordinance, 2001, income of persons (Individuals, Associations of Persons and Companies) is not taxed on the basis *i.e.* “a Pakistani” or ‘Foreign National’. Rather, income tax is chargeable on the income on the basis of Status (resident or non-resident) of a person.

- (i) An individual under section 82 of the Income Tax Ordinance, 2001 is resident, if he remains present in Pakistan for a period or periods, amounting in aggregate to 183 days or more in a tax year; or if he is an employee/official of Federal or a Provincial Government posted abroad in the tax year.
- (ii) An association of persons (AOP) under section 84 of the Income Tax Ordinance, 2001 is resident, if the control and management of the affairs of AOP is situated wholly or partly in Pakistan.
- (iii) A company is a resident company, under section 83 of the Income Tax Ordinance, 2001 if it is incorporated/ formed under any law in Pakistan or the control and management of the affairs of the company is situated wholly in Pakistan at any time in the year; and Provincial and Local Governments are also classified as resident companies.
- (iv) A non-resident person under section 81 of the Income Tax Ordinance, 2001 is one who is not a resident person for a tax year.

- (v) Pakistan source as well as foreign source income of a resident person is chargeable to tax, whereas in case of a non-resident person only Pakistan source income under section 101 of the Income Tax Ordinance, 2001 is chargeable to tax.
- (b) (i) Under section 2(36) of the Income Tax Ordinance, 2001, any person (other than an individual) may apply for registration as a non-profit organization (NPO). This status is granted, if NPO is established for religious, educational, charitable, welfare or development purposes or for promotion of an amateur sport, and is formed/registered under any law as an NPO and approved by the Commissioner Inland Revenue under section 2 (36) of the Income Tax Ordinance, 2001 read with Rule 211 of Income Tax Rule, 2002. On recognition (through an elaborate process of examination) as a Non-Profit Organization is exempted from Income Tax.
- (ii) Specific exemptions (on case to case basis) from income tax have also been provided under Second Schedule to the Income Tax Ordinance, 2001, to certain persons. Particulars of such entities have been provided at (**Annex-I**).
- (iii) NPOs are exempted mainly on the grounds that these are not profit earning organizations and these work for the betterment of the general public and down trodden people of the society. A list is placed at (**Annex-II**).

9. ***Prof. Khurshid Ahmed:** (Notice received on 20-05-2010 at 10:30 a.m.)

Will the Minister for Finance, Revenue and Planning and Development be pleased to state:

- (a) the details of relief provided to the pensioners during the financial years 2008-09 and 2009-10; and*
- (b) whether it is a fact that there was some discrimination in the said relief on the basis of year of retirement, if so, whether there is any proposal under consideration of the Government to abolish that discrimination in the budget for next financial year?*

Ms. Hina Rabbani Khar: (a) Government has allowed increase in pension to the pensioners during 2008-2009 and 2009-2010 as under:—

2008-2009 @20%
2009-2010

- (i) Pensioners who retired on or before
30-06-1999 20%
- (ii) Pensioners who retired after 30-06-1999
onwards 15%

(b) There was no discrimination in the said relief on the basis of year of retirement. During 2009-2010 higher rate of increase in pension was allowed to old pensioners in order to reduce the gap of pensions between old and new pensioners.

10. ***Col. (R) Syed Tahir Hussain Mashhadi:** (Notice received on 20-05-2010 at 10:40 a.m.)

Will the Minister for Commerce be pleased to state:

- (a) *the trade deficit of the country from June 2008 to June 2009 and June 2009 to 1st April, 2010;*
- (b) *the reasons of the said deficit; and*
- (c) *the steps being taken by the Government to reduce the deficit?*

Makhdoom Amin Fahim: (a) The country had a trade deficit of US\$ 19.249 billion in the period June 2008 to June 2009; the trade deficit during the period June 2009 to April 1, 2010 was US\$ 14.040 billion.

(b) Escalation in fuel and food items prices increased the import bill in 2008-09. Our import mainly comprised of essential items like petroleum, edible oil and wheat on one hand and machinery and raw material on the other hand; import of neither the former nor the latter can be curtailed. Coupled with higher imports, reduction in export growth due to global economic slowdown in our major market are the major reasons for trade deficit.

(c) To discourage non-essential imports and to encourage/ facilitate and promote exports and thereby decreasing the deficit the government took following measures:—

- ◆ Imposition of duty on non-essential/luxury items *w.e.f.* August 27, 2008
- ◆ Incentivizing exports by providing concessionary financing, zero-rating of exports, duty free import of raw material under special schemes to facilitate manufacturing for exports, development of export clusters.
- ◆ Initiation of trade diplomacy measures for getting better market access viz. Free Trade Agreements and Preferential Trade Agreements with different countries

Minister Incharge of the Cabinet Division: Government has already launched a comprehensive social safety net programme i.e., Benazir Income Support Programme, for serving the under-privileged sections of society. BISP's initiatives are:—

- (i) Monthly cash grant of Rs.1000 per beneficiary/poor family.
- (ii) Waseela e Haq as long term interest free loan of Rs. 300,000 for the BISP's beneficiaries.
- (iii) Emergency relief package, for earth quake effectees, IDPs, and bomb blast victims.
- (iv) Accident/ health insurance (Waseela e Sehet).
- (v) Vocational/technical training (Waseela e Rozgar).

122. ***Mr. Muhammad Talha Mahmood:** (Notice received on 25-05-2010 at 08:40 a.m.)

Will the Minister for Finance, Revenue and Planning and Development be pleased to state:

- (a) the rate of profit paid by the Pakistani Banks to their account holders on PLS accounts during the last five years with bank-wise and year-wise break up; and*
- (b) whether there is any proposal under consideration of the Government to fix minimum limit of profit on the said accounts, so, its details?*

Ms. Hina Rabbani Khar: (a) Bank wise and year wise break-up of profit paid by commercial banks to their account holders is at Annexure-A.

(b) The proposal for fixation of profit on PLS accounts was earlier considered by State Bank of Pakistan (SBP) in the year 2008 and banks have been advised to offer a minimum of 5% rate of return on their PLS deposits *w.e.f.* June 1,2008. The said was done keeping in view the difficulties of the depositors with regard to the low rate of return being offered by the banks. No fresh proposal in this regard is under consideration.

123. *** Begum Najma Hameed:** (Notice received on 25-05-2010 at 09:00 a.m.)

Will the Minister for Finance, Revenue and Planning and Development be pleased to state:

- (a) the amount of loans obtained from IMF during the present regime; and*
- (b) the purposes for which the said loans were obtained?*

Ms. Hina Rabbani Khar: (a) Pakistan entered into 23 month Stand by Agreement (SBA) with IMF for financing of SDR 5.169 billion (US\$ 7.6 billion) in November, 2008. In Board meeting held on August 7, 2009, IMF approved an augmentation of SBA of SDR 2.067 billion (equivalent to US\$ 3.236 billion), bring the total financial support to the tune of SDR 7.236 billion (about US\$ 11.325 billion). Up-till now Pakistan got disbursement of US\$ 8.70 billion after successful completion of four reviews held in May & July and November, 2009 and in February, 2010.

(b) The IMF resources, by definition, are meant for Balance of Payments support and as such the amount received by Pakistan under the Fund's facilities is used to finance essential imports and shore up the country's FE reserves. However, Pakistan also go bridge financing to use in the budget if FODD pledges are not materialized.

Will the Minister for Commerce be pleased to state the names and value of the items traded between Pakistan and Afghanistan under Afghan Transit Trade Agreement during the last three financial years?

Makhdoom Amin Fahim: The bilateral trade between Pakistan and Afghanistan is not governed under the Afghan Transit Trade Agreement (ATTA). The ATTA only obliges Pakistan to grant transit facilities to Afghanistan's global trade through the territory of Pakistan.

The details of bilateral trade between Pakistan and Afghanistan for last three years are Annexed.

OGRA

(a) No. The Oil and Gas Regulatory Authority is observing the provincial quota for appointments.

NEPRA

NEPRA has observed Provincial quota as stipulated in Regulation 11 of NEPRA Service Regulations (NSR), 2003 till 9th June, 2010. After receiving a Policy Directive of the Prime Minister, the Authority is strictly observing the Provincial quota as fixed by the Federal Government from time to time.

OGRA

(b) Total number of persons working in OGRA is 215. Province-wise breakup of the employees is at **Annexure-I**.

NEPRA
