76. **\*Dr. Muhammad Ismail Buledi:** (Notice received on 02-02-2009 at 08:35 a.m.)

*Will the Minister for Housing and Works be pleased to state:*

- (a) *whether is it a fact that Prime Minister's housing / flats scheme at Islamabad has been launched by Pakistan Housing Authority for the Government employees in BPS-1 to 16 and BPS-20 to 22;*
- (b) *whether it is also a fact that no such scheme has been launched for the Government employees in BPS-17 to 19, if so, its reasons; and*
- (c) *the time by which the said scheme will be launched for the Government employees in BPS-17 to 19?*

**Mr. Rehmatullah Kakar:** (a) PHA has launched Housing Scheme for Low Paid Federal Government Employees working in BPS-1-16 at G-10/2 and G-11/3, Islamabad under the Prime Minister's Housing Programme. Allotments have been made through balloting to successful applicants.

As regards housing scheme for BPS-20-22, it is submitted that no scheme is being launched exclusively for BS-20-22. However, as per approval of the Prime Minister, housing schemes for Federal Government Officers (BPS-17 & above) are being under taken in following phases:

*Phase-I.*—Eligible officers of Federally Constituted Occupational Groups, ISI, 1B, Supreme Court and Parliament Houses (National Assembly & Senate Secretariat) in BPS 17 & above.

*Phase-II.*—All other eligible Federal Government Officers (BS 17 & above).

(b) It is clarified that housing schemes are being under taken as per approval of Prime Minister for all Federal Government Officers (BS-17 & above) in two phases as explained above.

(c) Scheme for officers who fall in Phase-I is being launched however, Phase-II of the scheme shall be launched on availability of land.

*Will the Minister for Petroleum and Natural Resources be pleased to state:*

- (a) *the number of oil depots at present in the country; and*
- (b) *the number of said depots closed down during the last two years indicating also the reasons for their closure?*

**Dr. Asim Hussain:** (a) Total 12 oil depots are operational in the country. 13th Gwadar Depot will be developed when required. List of depots is at Annex-I.

(b) 17 depots were closed down during the last two years to reduce dumping and hence save consumers from the additional Inland Freight Equalization Margin (IFEM) cost.

*Will the Minister for Petroleum and Natural Resources be pleased to refer to the Senate Starred Question No. 147 replied on 18th May, 2007 and state:*

- (a) *whether it is a fact that the work of supply of natural gas to village Sadwal Teshil and District Chakwal was to be completed upto December 2007, but the same has not been completed so far, if so, its reasons;*

- (b) *the names and designation of the officers responsible for the delay in completion of the said work and the action taken against them; and*
- (c) *the time by which the said work will now be completed?*

**Dr. Asim Hussain:** (a) Yes it is a fact that the work on supply of natural gas to village Sadwal Tehsil & District Chakwal was to be completed by December 2007 but it has not been completed so far due to company's physical and financial constraints.

(b) SNGPL has informed that the matter is being further looked into for non completion of the project in time and further action will be taken in light thereof.

(c) The Phase-I of the project involving 16 km of distribution network, would be completed/commissioned by 31st May, 2009.

The work for phase-II of the project for laying of 6 km network is in progress and is anticipated to be completed by 30-09-2009
