5. ***Mr. S. M. Zafar:** (Notice received on 29-06-2011 at 08:50 a.m.)

Will the Minister for Inter Provincial Co-ordination be pleased to state the steps being taken by the Government to invite Indian Hockey and Cricket teams for playing matches in Pakistan?

Minister for Inter Provincial Co-ordination: Mr. Muhammad Asif Bajwa, Secretary General, Pakistan Hockey Federation and Mr. Narinder Batra, Secretary General Indian Hockey, Federation met at Lausanne/Switzerland during the FIH Congress and discussed the matters relating to promotion of hockey in Sub-Continent. Both agreed to play series of matches in either of the countries to promote Hockey and to enhance friendly relations between the two countries.

The Pakistan Cricket Board (PCB) is in touch with the Board of Control for Cricket in India (BCCI) for revival of bilateral cricket ties between the two countries. At

the recent meeting between PCB and BCCI in Hong Kong, the two Boards discussed the possibilities of resuming cricket fixtures.

PCB referred BCCI to recent statements from their government in the media expressing consent for starting cricket ties. BCCI awaits a green signal from their government in this matter. PCB maintains regular contact with our Ministry of Foreign Affairs and our High Commission in New Delhi with a view to restarting cricketing contacts.

PCB plans to continue discussions with BCCI for finalizing a cricket series between two countries in March/April, 2012 where a slot for this series is reserved.

Will the Minister for Inter-Provincial Co-ordination be pleased to state:

(a) *the details of expenditures of Ministry of Inter-Provincial Coordination, its attached departments and subordinate offices during the last three years with head-wise and year-wise break up; and*

(b) *the steps taken / being taken by the Government to reduce the said expenditure?*

Minister for Inter-Provincial Co-ordination: (A) The Statement showing the details of expenditure of Ministry of IPC incurred during the last three years (2008-09, 2009-10 & 2010-11) with head-wise and year-wise breakup is annexed.

(b) The instructions of the Finance Division regarding austerity measures were strictly followed and no excess expenditure under any object head was incurred. However Supplementary Grants were requested for creation of new posts and expansion of Ministry due to reallocation of functions in the process of devolution and to incurred expenditure on deliberations of the Implementation Commission.

Dr. Abdul Hafeez Shaikh: (a) The Number of officers in BS-17 and above are at Annex-I.

(b) The number of vacant posts in BS-17 & above in FBR are placed at Annex-II. The Regional/Provincial share in BS-17 is maintained by Establishment Division in accordance with prescribed Quota placed at Annex-III. Vacant positions are regularly reported on annual basis for recruitment by FPSC.

Will the Minister for Finance, Revenue and Planning and Development be pleased to state:

Dr. Abdul Hafeez Shaikh: (a) (i) Loans of Rs. 5 million and above given/dispursed by SME Bank Ltd against mortgage of Urban Property are Rs. 1.672 billion with 130 numbers of loan accounts/borrowers and Rs. 1.454 billion are presently outstanding. Detail is at **Annex-A**.

(ii) Loans of Rs. 5 million and above given/disbursed by SME Bank Ltd against mortgage of Rural Property are Rs. 0.192 billion with 21 numbers of loan accounts/borrowers and Rs. 0.164 billion are presently outstanding. Detail is at **Annex-A**.

(b) An amount of Rs 363 million has been written off by SME Bank since 2008. Detail is at **Annex-B**.

Minister Incharge of the Cabinet Division: The prime Minister has been pleased to approve the proposed Compulsory Monetization of the Transport Facility for the Civil Servants (BS-20 to BS-22) on 3rd December, 2011. The precise details of the policy parameters of the proposed monetization are being finalized in consultation with the Finance Division, which will be issued shortly.

Dr. Abdul Hafeez Shaikh: Section 216 of the Income Tax Ordinance, 2001, read with clause (xv) of Rule 47 of the Rules of Procedure and Conduct of Business, 1988 debars disclosure “in relation to any matter in respect of which there is a constitutional or statutory obligation not to disclose information”.

5. ***Mrs. Suriya Amir Uddin:**(Notice received on 22-09-2011 at 11:00 a.m.)

Will the Minister Incharge of the Cabinet Division be pleased to state:

(a) *the date on which Development of University of Balochistan, Quetta, scheme was launched indicating also its present status;*

(b) *the estimated cost of the said scheme indicating also the amount released and spent so far on it with head-wise break up; and*

(c) *whether the scheme will be completed in the stipulated period, if not, its reasons and the revised/expected date of its completion?*

Minister Incharge of the Cabinet Division: (a) The project titled “Development of University of Balochistan, Quetta” was approved by ECNEC on 30-11-2006. The administrative approval was issued on 30-12-2006. The duration of the project is 60 months.

(b) The capital cost of the project is 971.878 million. Rs. 559.660 million has been released so far out of which Rs. 544.545 million has been utilized. The head-wise break up is given at Annex-1.

(c) The scheme will not be completed in stipulated time and is expected to continue till December 2013. The project involves 65 scholarships for faculty development. Out of these, 7 scholars have completed their studies. 58 scholars are still abroad and will complete their studies in Dec. 2013.

Minister Incharge of the Cabinet Division: (a) BISP has awarded Nationwide Poverty Scorecard Survey contracts to the following Organizations after following stringent and comprehensive procurement rules/procedures of the World Bank as the survey exercise is being funded under Technical Assistance of the World Bank. The country was divided into seven clusters while awarding the contracts. Cluster-wise division of the survey areas/regions and allocation of the same to different Organizations is as follows.

*Under Aghaz-e-Haqooq Baluchistan Package, Government of Pakistan issued instructions to BISP for conducting survey in Baluchistan on priority basis. The survey exercise in major parts of Baluchistan was completed in 3 months time.

Dr. Abdul Hafeez Shaikh: (a) The amount received from Asian Development Bank (ADB) during the year 2010 is **US \$ 281.85 million** and during the year 2011 is **US \$ 381.83 million**.

The criteria adapted for providing assistance to Ministries/Divisions/ Departments is placed at **Annex-II**.

Annex-II

Criteria for External Financing is as follows:

- (a) Bridging the funding gap for development.
- (b) Projects are approved by the CDWP and ECNEC with specific foreign component.
- (c) Provincial Government/Federal Ministries feel constrained by domestic resources and project implementation is a priority.
- (d) Most external assistance is focused on energy, water, infrastructure development, education and health sectors.

Dr. Abdul Hafeez Shaikh: There is no specific proposal/ project for provision of clean drinking water to Gwadar area at present. However, a PC-I of the project titled "Provision of Drinking Water to the Fishermen Communities along-with Balochistan Coastlines" costing Rs. 445.000 million has been received from Govt. of Balochistan

which is under examination. The said project would be financed if foreign assistance is available.

Minister Incharge of the Cabinet Division: (a) Initially, the offices of BISP were partly housed in a small part of the NAB Building and a rented building at Embassy Road, Islamabad. However, after devolution of Ministry of Population Welfare, F-Block, Pakistan Secretariat was allotted to BISP. In order to make the building suitable for operational needs of BISP, necessary alteration and renovation has been carried out at a cost of Rs. 35,417,712/-. This includes establishment of call centre, data centre, networking, fencing and related miscellaneous work as well as unfinished works like renovation of Auditorium. The rented building at Embassy Road has been retained to locate the Complaint Centre which could not be shifted to the Secretariat building because of security concerns conveyed by the relevant agencies against the risk of hundreds of people visiting F-Block every day. Most of the Regional, Divisional and Tehsil offices are housed in rented buildings and no expenditure has been incurred on their renovation. Details are attached as Annex-I.

(b) At present 1967 persons are working in BISP at its Headquarters and the Regional Offices. There are two categories of employees in BISP. One category includes deputationists from different departments of Government of Pakistan. The other category includes employees who have been hired on contractual basis through open competition. Details are placed at Annex-II.

Afterwards the Managing Directors appointed by different authorities has been considered in BOG meeting dated 25th January 2008 and decided that Executive Committee should examine the appointments of *Ex-MDs* (**Annex-A**). Accordingly the Executive Committee had approved all the appointments of Managing Directors since 1988 in the light of directions of BOG. the list of Managing Directors of NTD is at **Annex-B**.

Minister Incharge of the Cabinet Division: (a), (b) and (c) Benazir Income Support Programme (BISP) within a short span of three years has made remarkable progress by providing much needed relief to 6 million poor families including Internally Displaced People (IDPs), floods & earthquake affectees and bomb blast victims all across Pakistan. The number of beneficiary families is expected to increase up to 7 million once the data processing of the nation-wide targeting survey is completed.

A very important highlight of BISP's success was its commitment to reach out to millions of its beneficiaries in order to inform and educate them about various initiatives and benefits of the programme. BISP beneficiaries present in every nook and corner of the country belong to deprived segment of society which is not much literate and does not have access to a solitary source of information. Thus, it was taken as a challenge to run

awareness campaigns relying on various sources of communication to keep them well informed, updated and aware.

It was of vital significance to reach out to them as per their media habits through available resources i.e. newspapers, radio and TV channels working at various levels of audience outreach i.e. national or regional. Relying on single mode of communication or specific channels or newspapers could prove a communication failure which was well avoided.

The only criteria that was adopted for advertisements was to make sure that the message of BISP must reach loud and clear to all its beneficiaries present throughout Pakistan from outskirts of Baluchistan to far flung areas of Gilgit Baltistan, Kashmir or FATA. Therefore, these advertisements about the initiatives of the programme were published varying from the national level newspapers to the newspapers in regional languages of all the provinces i.e. Punjab, Sindh, Baluchistan, Khyber Pakhtoonkhwa, Gilgit Baltistan along with AJ&K and FATA. Same is the criteria for the selection of radio and TV channels for advertisements i.e. all the Electronic channels were given ads as per their coverage at the national and regional level so that beneficiaries do not miss out useful information. Accordingly Ads were published and run on hundreds of Newspapers, TV Channels and Radio/FM. Besides these many other methods such as Civil Society Seminars, discussions and Newsletters etc. were also adopted for public awareness.

There are a large number of newspapers and TV channels in which BISP advertisements have been published or run in the last three years. The data for desired newspapers or channels regarding BISP advertisements can be made available for information if such channels or newspapers are specifically mentioned.

(b) As per decision of the Honorable Court, the cases of teachers having rendered three years or above continuous service on contract/daily wages basis were forwarded to FPSC to ascertain their eligibility for appointment. In the first phase 33 cases were forwarded out of which 22 have been recommended for appointment. In second phase, cases of 287 teachers were referred to FPSC. However, on recommendations of Cabinet Sub-Committee on Regularization of contract and daily wage employees, FPSC has been requested to stop the process as the cases would be scrutinized by the committee itself. The cases of teachers sent to FPSC under the directions of Supreme Court have now been sent to Cabinet Committee for consideration.

90. ***Eng. Malik Rashid Ahmed Khan:** (Notice received on 13-10-2011 at 11:50 a.m.)

Will the Minister for Finance, Revenue and Planning and Development be pleased to state the development funds allocated for FATA for the fiscal year 2011-12 indicating also the amount released so far?

Dr. Abdul Hafeez Shaikh: An amount of Rs. 10.000 billion including Rs. 0.476 billion foreign loan, has been allocated for FATA ADP 2011-12 through block allocation under federal PSDP 2011-12. Out of rupee allocation of Rs. 9.524 billion, an amount of Rs. 2.572 billion has been released so far.

The Federal Government has decided that the size of FATA development programme may be enhanced during the financial year 2011-12 based on the spending capacity of FATA. After entire allocation of Rs. 10 billion is spent on development of FATA, the Federal Government may provide additional funds upto maximum level of Rs. 15 billion during 2011-12.

Due to excess appointment, Naib Qasids were adjusted against other cadre posts, but the AGPR, Islamabad refused to disburse the salaries to those officials who were adjusted against other cadre posts. So it is a fact that a few of them have not been paid salaries since their appointment.

Regarding the time frame to release the salaries, AGPR, in the light of Judgment passed by the FST, has assured that the issue will be resolved, on receipt of authentic list of appointees of 2009 from FDE through CA&DD and advised that the case for obtaining of NOC of Establishment Division be processed. FDE is compiling the data and will be forwarded to the AGPR on emergent basis. This long outstanding issue of on payment of salaries will be resolved shortly.

(c) The normal processing time is 30 to 45 days subject to completion of required formalities as per credit policy in vogue by the applicant.

Remaining commitments will be disbursed over the life cycle of the projects / programmes. Overall foreign assistance received during 2010-11 is **\$2,601.0 million**, the details are at **Annex-II**.

(d) 845 employees availed Voluntary Separation Scheme (VSS).

(e) Since surplus pool does not exist any more, therefore, requisite information may be considered as Nil.
